 April 2023, the Agency reported 126,764 inmates incarcerated in 98 TDCJ facilities and 77,000 parolees under supervision through 67 parole offices

- 29,907 employees, of which
 - 20,205 of those are correctional employees and ~1200 are parole officers
- Operating Budget: ~\$3.4B
- ~12M pieces of paper mail/year
- ~4.7M eMessages sent via inmate tablets in Q1 of 2023

 - Onsite!
- <u>Criteria</u> Technology is one criteria, being a solid, dependable, and <u>honest partner</u> is just as important!


