

# **OMS Modernization Journey**

- Funding, selecting, and delivering an OMS modernization initiative is complex.
- Selecting a vendor to modernize your aging OMS is a daunting task.
- It takes years of planning & budget allocation.
- An extensive RFI/RFP process & contract negotiations.
- A multi-year risky and challenging implementation is facing unexpected issues!

# Things to Look for – Product Development Approach

- Regular Product Updates
  - Multiple releases per year to avoid critical functional and technology gaps between the production release and the latest product version available.
- Product Roadmap
  - Product roadmap is available and shared within the customer base, so the customer is prepared and aware of upcoming product updates.
- User Community
  - Access to the user community and a possibility to influence the product roadmap.
- Certification Programs
  - Certification programs are available and maintained at the individual level.

# Things to Look for – Technology



- Technology Upgrade Availability
  - Product technical foundations are updated regularly to avoid unsupported/outdated infrastructure in production.
- Re-configurable
  - Initial configurations can be modified by the customer and will not require a new product version or a change request.
- Backward Compatibility
  - When a new product version is available, it can be deployed in production easily without losing customers' specific configurations and custom code.
- Open & Standard APIs
  - Back-end features are available via an open, standardized and secured API layer.

# Things to Look for – Hosting & Compliance



- Security Updates
  - Product security is maintained and assessed regularly and validated by independent auditors (such as ISO certifications and independent intrusion tests).
- Robustness of Solution
  - Proven high availability, performance, and volume.
- Cloud/CJIS Certified
  - Built on recognized and widely accepted industry standards.
- ISO Certified
  - Proven standardization and quality assurance.
- Scalability
  - Ability to handle millions of transactions each year.


## Frequent Software Releases

- VADOC conducts 3 major releases per year.
- VADOC has also combined releases due to legislative priorities. This creates risk due to the number of changes and amount of required testing.
- VADOC stood up an additional testing environment to allow a longer testing window and parallel testing of releases.


#### Planned Release Content - Roadmap

- VADOC develops CR working with business stakeholders.
- Abilis provides high level estimate of the CR.
- VADOC works with Abilis developing a solution.
- VADOC has a IT Steering Committee that approves CR funding.


