Managing Jail Population

- Like most jurisdictions across America, managing the jail population is an arduous task.
- There is a constant struggle to find bed space.
- There was a need for a way to manage jail overcrowding without sacrificing public safety.

Compliance

 There was a need for a mechanism to comply with the Missouri Supreme Court ruling regarding bail and conditions of pretrial release.



A Willingness to Try Something New - For Free

St Louis County was open to trying a new approach to managing pretrial release

St Louis County sought a way to manage the pretrial population to comply with the recent Missouri Supreme Court ruling surrounding bail and conditions of release.

Because the idea was largely unproven in the market, they sought a no-cost pilot.

eHawk was the clear winner.

After one year, eHawk has helped reduce pretrial jail days by more than 60% in St. Louis County




- RePath is a Software-as-a-Service (SaaS) solution hosted on AWS (Amazon Web Services)
 - Secure, serverless, cloud-based architecture with endto-end encryption in transit and at rest
 - No integration with other systems is required
 - No technical effort required from your staff to begin a pilot. eHawk provides all necessary support and resource
 - If the pilot is successful, eHawk can integrate with legacy systems to improve efficiency
- Agency configuration determines functionality
- Clients use an iOS/Android phone app on their personal device
 - This is the key to adoption, rapid implementation, and cost savings that drive results.



- The RePath app allows participants to easily maintain compliance with court ordered conditions of release or terms of probation
- The platform includes a broad spectrum of features to encourage compliance and benefit the participant
- All data is accessible by officers and agency personnel through a web platform and a mobile application
- Integration can be accomplished to drive efficiencies
- Access to eHawk's fully staffed monitoring center
- Reduces reliance on paper-based systems









Exclusion Zones

Provides warnings to participants as they approach prohibited zones and alerts the supervisor in case of violation

- Enhanced tracking








Inclusion Zones


- Zone creation by time

- Notifications








Automated Court Reminders










Community Resources

- The RePath app provides direct access to support services for participants
- Includes contact information and physical address of these services, while also providing a direct link with directions to the service.







Communications

- Text or video chat conducted within the app
- Automatically recorded in participant record
- Send a mass SMS to multiple participants (e.g., please report for drug testing/court closures)
- Can be initiated by either participant or supervising authority





Implementation of St. Louis County consisted of 6 weeks of on-site support.

- Met with judges to help them utilize the program in a way that best fit their courts
- St. Louis County & eHawk worked closely together to structure a program to best fit their needs
- eHawk coordinated with the different divisions within St.
 Louis County to provide training
- eHawk provided initial assistance with enrolling participants in the program
- eHawk continued to provide training and support off-site
